This new strategy of the administrative branch of the Ministry of Agriculture and Forestry sets down the strategic objectives which guide our work to serve the Finnish consumers, while enhancing biodiversity and the viability of the rural areas.

Our aim is that


- ★ Finland utilises renewable natural resources in a responsible and sustainable way and as an international pacemaker
